General Guidelines			
a. The manuscript is written in A4 sized paper (8.3" x 11.7"),			
font style: Times New Roman, font size: 10, double spaced,			
margins at 2.54 cm in all sides, and aligned right.			
 b. The manuscript is 'spell checked' and 'grammar checked' and language used is American English. 			
 The number of pages is be limited to a total of 30 pages and it is numbered on the top-right corner. 			
Title page			
 a. Title page contained the following: Running title, Author's information (Given name, middle initial, family name; Below the author/s profile is their affiliation/University), Corresponding author's information to whom inquiries should be directly sent (Complete name, affiliation/University, postal address, phone number, and email address) 			
 b. The title of the paper should be written in sentence form in bold and above centered. 			
c. Only the first words of the title should be capitalized.			
Abstract			
 a. Number of words is limited to 250 and written in one paragraph. 			
 b. Included are the facts and conclusion included in the manuscript. 			
c. Keywords are lower cased, arranged alphabetically and not more than six (6) words.			
Introduction			
 a. Sufficient information on the rationale of the study, general information, gaps or significance, and the general objective are provided. 			
Methods			
 a. Comprehensive description of the study site, design of the study, sampling procedure, materials used, and data analysis conducted are included. 			

b.	Sub-headings are included to distinguish the different methods used for each objective.		
C.	Brand/model and country of chemicals/equipment must be provided.		
d.	Equations are inserted using the Equation Editor.

b.	Full information of molecular methods is presented which

	on the date of publication with the latest being the last (e.g.

e.	Comma must be used to separate citations of different		
	references with the same author (e.g. A 2009, 2019).		
f.	Citing a journal articles - Name(s) and initial(s) of author(s),		
	year, full title of research article (in sentence form), name of		
	the journal (not abbreviated), volume number, issue number		
	(if given), range of page numbers, DOI number (if available)		
	and/or web link.		
g.	Citing books - Name(s) of author(s), year of publication, full		
	title of the book (capitalize each main word), publisher, place

n.	Citing an electronic book - Rollin, BE. The unheeded cry:

k.	Citing in press articles – Author's family name, initial names of the author, year, title of the article, journal that accepted the paper.		
I.	Citing in press articles – Author's family name, initial names of the author, year, title of the article, journal that accepted the paper.		
m.	Citing a source within a source - For example, Unsworth refers to previous work by Halliday on linguistics, the citation might read thus:(Halliday, as cited in Unsworth, 2004, p. 15)		
n.	Citing a test scales and inventories – For example, Philippine Statistics Authority (PSA). (2020). Commercial Fisheries: Value of Production [Database]. OpenSTAT. https://openstat.psa.gov.ph/PXWeb/pxweb/en/DB/DB2EFS/0022E4GCCP0.px/t able/tableViewLayout1/?rxid=bdf9d8da-96f1-4100-ae09-18cb3eaeb313

p.	Citing a paper in proceedings – For example, PANTASTICO EB, MENDOZA DB. 1988. Climatic constraints to rice production in the Philippines. In: Cardenas A. editor. Climate and Rice Production. Proceedings of a Symposium on the Agrometeorology of the Rice Crop at the 27th meeting of the World Meteorological Organization; 1987 April 8-14; Los Banos, Laguna, Philippines: International Rice Research Institute. p. 107–119.		
q.	Citing patent or utility model – For example, PAULETTE T. 1998. Pigments manufactured from minerals. Can Patent 2, 186, 964.		
r.	Personal communication - Should appear only in text parenthetically with the names of persons who supplied the information. They should not be listed in the References section.
